CIVIC VOICE RESPOND TO GOVERNMENT'S NPPF DOCUMENT

Civic Voice welcomes the new National Planning Policy Framework but remain cautious over loss of so much detail from PPS statements

The Government yesterday published its long awaited National Planning Policy Framework (NPPF) and Civic Voice has been pleased to have worked so closely with Government over the past six months to secure several positive improvements from the original draft document.

Paula Ridley, Chair of Civic Voice, said *“There was widespread concern about the Government’s planning reforms which, if they had been kept as in the draft it would have biased decisions and put everyday England at risk. The Government have clearly listened to the 14,000 stakeholders who responded to this consultation. We congratulate them for that.”*

In addition, Civic Voice is pleased to see the following in the NPPF:

- ☛ Enshrining high-quality design as a core planning principle
- ☛ Greater clarity over the definition of sustainable development
- ☛ The announcement of transitional arrangements to allow local authorities to develop Local Plans
- ☛ Government recognising the intrinsic value of non-designated countryside
- ☛ Strengthening of provisions to encourage the development of brownfield sites
- ☛ Strengthening of the Town Centre First Policy and placing town centres at the heart of vibrant and sustainable communities
- ☛ A strengthening of policy on design and providing greater weight for the advice of design review panels
- ☛ We also believe that the level of protection that PPS5 gave to heritage has been maintained in the NPPF.

Nonetheless, Civic Voice still remains cautious about the final document

Civic Voice Planning Chair, Dave Chetwyn said “*The National Planning Policy Framework is a vast improvement on the draft, creating a more sensible balance between economic, social and environmental matters. However, we have some concerns that the loss of so much detail, with the Planning Policy Statements being replaced by a 50 page document. This gives more scope for interpretation and possibly legal challenge and may have the opposite effect to that intended*”

Civic Voice have said all along that there is no conclusive research that planning policy is a particular constraint on economic development and we hope the conversation can now move on from a planning v growth argument to giving the necessary support to local authorities and communities to ensure they have plans in place and up to date.
